The Commission administers federal funds from the United States Department of Housing and Urban Development (HUD), including CDBG, HOME, ESG and CDBG-CV, on behalf of the County of Sonoma, the Town of Windsor, and the cities of Cloverdale, Cotati, Healdsburg, Rohnert Park, Sebastopol, and Sonoma (collectively, the "Urban County"). This NOFA, the FY 2025-2026 Federal Funding Policies, and other associated guiding documents govern the distribution of federal funds. Please review these materials carefully for important information regarding project/program eligibility and application procedures. Prior to execution of a funding agreement, all federal awards are subject to completion of an environmental review in accordance with applicable HUD regulations and the National Environmental Policy Act (NEPA). Subrecipients must also comply with Section 3 requirements, which mandates that HUD-supported housing and community development activities provide construction-related training, employment, and contract

opportunities to low-income individuals, businesses that are owned by low-income individuals, or businesses that employ low-income individuals. Additionally, all activities awarded federal funds must comply with the Build America, Buy America Act (BABA Act).

Permanent supportive housing and housing serving special needs populations are eligible and workforce ownership housing serving households with 120 percent of the Area Median Income. Only projects located outside the city limits of Petaluma and Santa Rosa are eligible for funding. Preference will be given to eligible workforce ownership housing projects. Eligible projects that are ready to proceed towards construction will be given preference.
CFH	\$1,500,000	Development, preservation of affordable housing, including permanent supportive rental housing; below market-rate homeownership projects, housing serving special needs populations, emergency shelters, transitional housing, group homes, and other type of congregate facilities. Eligible projects that are ready to proceed towards construction will be given preference.

#### **Application Due Date**

All funding applications must be submitted to the Commission by 5:00 P.M. on Thursday, April 17, 2025. Only applications submitted through the Commission's online portal will be accepted. Hard copy applications will not be accepted.

### **Funding Priorities**

The Community Development Commission Loan Policies, CFH Policies, PLHA policies, Homeownership Policies, and Federal Funding Policies guide the allocation process of these funds in an effort to further the strategic plan goals stated in the Five-Year Consolidated Plan. Prospective applicants are strongly encouraged to review these policies prior to application submission. The Commission will recommend funding awards to the most competitive proposals that adhere to the applicable funding policies and align with the goals of the Consolidated Plan.

#### **Selection Process**

All applications will be reviewed and evaluated by Commission staff, who will then prepare an analysis for consideration by the Community Development Committee (CD Committee) and the Cities Towns Advisory Committee (CTAC). The committees will hold a concurrent public meeting to discuss the staff reports, accept comment from applicants and the public, provide feedback to staff, and make funding recommendations that will be incorporated into the draft FY 2025-2026 Action Plan and FY 2020-2021 Action Plan Substantial Amendment. The CD Committee will review preliminary funding recommendations for LMIHAF, CFH, and PLHA. The committee meeting is scheduled for May 21, 2025 at 10:00 A.M. and will be a hybrid meeting. All applicants that have applied for funding must be present at the committee meeting to be considered for funding. Applicants may attend in-person or virtually on Zoom.

The CD Committee and CTAC will hold concurrent public hearings on **June 25**, **2025**, at 10:00 A.M. to make final funding recommendations for the draft FY 2025-2026 Annual Action Plan and draft FY 2020-2021 Action Plan Substantial Amendment. At this meeting, the CD Committee will also review and make funding recommendations to the Board on LMIHAF, PLHA, and CFH funding programs. All funding recommendations will be forwarded to the Board of Supervisors for review and approval.
