2. Approval of Minutes from previous meetings-Haunani Pakaki

4. Discussion: Updates since the March 2024 meeting–Brad Michnevich

- a. There are just over 250 youth on supervision, today. The count is trending upward and has nearly reached 2019 levels. It is unknown if it will continue trending upward.
- b. Juvenile Hall population is 65 today, which is higher than 2019 levels, though this includes 16 Secure Youth Treatment Facility (SYTF) youth (13 from Sonoma and 4 from other Counties), and some youth who might have been in Probation camp in prior years are likely now in Juvenile Hall.
- c. In 2023 and 2024 (estimated based on nine months of data) Probation received about 250 felony referrals and 150 misdemeanor referrals per year. Felony referrals are currently 25% above pre-pandemic levels, and Misdemeanor referrals are 50% lower. Court stats showed a 46% increase in petitions.
- d. Family Youth & Children (FYC) reports while their reporting numbers are down, but the acuity is much more severe
- e. At the last meeting a revised Charter was approved, reflecting the Assembly Bill (AB) 505 changes
- f. At the last meeting no members volunteered to be Co-Chair, and no motion was made to add a Co-Chair.
- g. The Annual Juvenile Justice Realignment Block Grant (JJRBG) Plan was timely submitted to the Office of Youth and Community Restoration (OYCR)
 - i. An Addendum was requested of several counties, including Sonoma County requesting additional disaggregated data, regional agreement partner information, and the names of housing programs or services available to the SYTF youths.
 - ii. The Addendum was sent in early August and accepted by the OYCR.

5. Updates: Developments in Juvenile Hall-Kilee Willson & Kris Hoyer

- a. SYTF population: 17, including 4 from other counties
- b. Youth in Less Restrictive Programs (LRP) after leaving SYTF: 4
- c. Sonoma County youth supervised in the community, not in LRP: 6
- d. Sonoma County youth All Proceedings Dismissed after SYTF: 6
- e. Total Sonoma County youth served in SYTF since Senate Bill (SB) 823 start: 33
- f. Juvenile Hall had its annual OYCR site visit on 9/5/2024
- g. Juvenile Hall also had its Board of State and Community Corrections (BSCC) targeted inspection on 8/27-8/30
- h. Female population today: 14
- i. Request For Proposals (RFP) for re-entry services, Treatment of Sexual Offending Youth, and Career-Technical Education
- j. Since September, resumed taking referrals from other currently contracted counties

- k. Use of Compass Academy is up-long-term population with a furlough option. SYTF Youth + Compass Academy youth = half of the population
- I. Juvenile Hall is continuing to work on getting youth into less restrictive programs
- m. BSCC visited twice this year including a recent visit during a power outage
- n. Trauma Counseling and Violence Prevention (TCVP) RFP and TSOY RFP ongoing, currently a bridge program for TSOY is happening with HOPE.
